Customer is responsible for having all equipment, drain plugs, etc. available to Prell Pool Service & Repair personnel on date of service, unless customer has ordered such items from Prell Pool Service & Repair and therefore shall be delivered upon date of service. Payment for additional items is also due upon the date of service. Prell Pool Service & Repair is not responsible for any plaster, coping or tile that has become loose, popped off, broken or cracked over the course of the winter when the pool is closed. It is the responsibility of the customer to keep the water pumped off of solid covers or to maintain the proper pool level in the pool for those with a mesh cover. Prell Pool Service & Repair is not responsible for any staining of the pool surface, which may occur over the course of the pools closure, due to organic or inorganic materials that may find their way into the pool. Prell Pool Service & Repair is not responsible for any wearing, tearing, or general damage of the pool cover, which may have occurred over the course of the pools closure.

Prell Pool Service & Repair agrees to service the swimming pool for the above named, who also agrees to pay for the service outlined. By signing this contract, the above named customer agrees to all terms and conditions described in this contract. The above also agrees to provide full payment upon day of service. The above also authorizes Prell Pool Service and Repair to bill the customer and agrees to pay Prell Pool Service & Repair for any necessary equipment not provided by the customer in order to complete pool opening. Prell Pool Service and Repair is not responsible for any additional work needed beyond that which is included or agreed to prior to date of service. Prell Pool Service & Repair must be informed of any special requests, other than the services included, prior to date of opening and is subject to additional charge.
